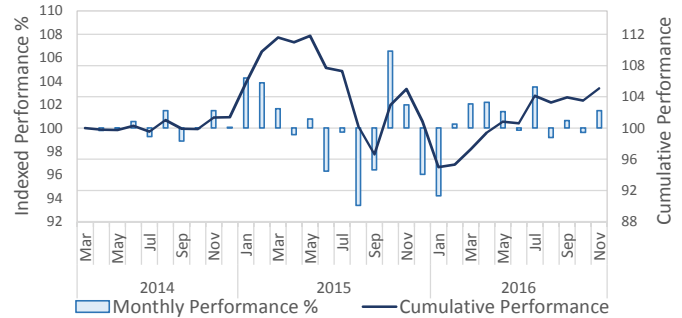


Eagle Global Opportunity Growth Fund VIII



- Preservation of capital is an investment objective of the Fund. Fund aims to maximise the total level of return for investors, minimising the volatility of the portfolio. It invests principally in money market, bonds, equities and investment funds.
- The Fund will invest in developed and emerging countries. The Company does not intend to have limits on the geographic asset distribution. The investment strategy consists of a top-down approach driven by macro-economic and fundamental research. Moreover, investments are often theme-based and remain focused on long-term capital growth.
- Equities offer above-average return potential over the long run. However, markets may witness high volatility and fluctuations in the short-term. The Fund is diversified across major currencies and its value may fluctuate due to currency movements.

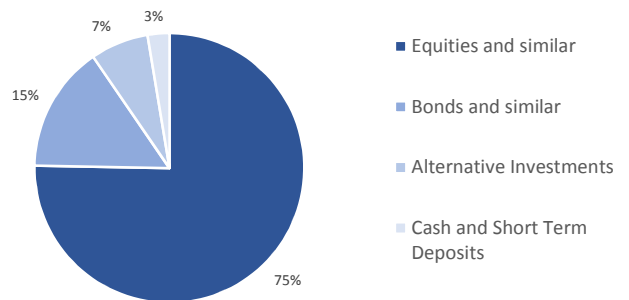
